a. Information You Provide

Standard message and data rates may apply based on your mobile carrier's rate plan. By opting in, you confirm that you are the authorized user of the mobile number provided.

d. Information Sharing

We do not share your phone number with third parties for their own marketing purposes without your consent. However, we may share it with our service providers who assist us in delivering SMS messages, provided they comply with strict data protection standards.
